Last year, we tiled the foyer of the office; this year, we will complete the project by tiling Joani's office and removing the old carpet. Approximate cost is \$900.



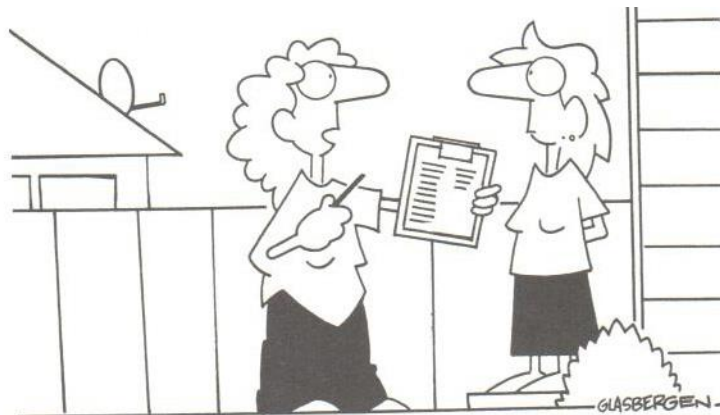
